LETTER OF INTENT FOR COOPERATION IN ELECTRIC VERTICAL TAKE-OFF AND LANDING (eVTOL) AIRCRAFT

BETWEEN THE

FEDERAL AVIATION ADMINISTRATION DEPARTMENT OF TRANSPORTATION UNITED STATES OF AMERICA

AND THE

NATIONAL CIVIL AVIATION AGENCY (ANAC) MINISTRY OF INFRASTRUCTURE THE FEDERATIVE REPUBLIC OF BRAZIL

WHEREAS, the Federal Aviation Administration (hereinafter referred to as "FAA") of the Department of Transportation of the United States of America, and the National Civil Aviation Agency of the Ministry of Infrastructure of the Federative Republic of Brazil (hereinafter referred to as "ANAC"), are each engaged in overseeing the airworthiness and flight safety of electric vertical take-off and landing aircraft (hereinafter referred to as "eVTOL");

CONSIDERING the Chicago Convention on International Civil Aviation of December 7, 1944, of which the United States of America and the Federative Republic of Brazil are signatories;

DESIRING to promote aviation safety and environmental quality;

DESIRING to promote technological development on aviation services;

NOTING common interest in the safe operation of civil aircraft;

NOTING the recent increase in activities related to the development and implementation of new technologies to the civil aviation system;

RECOGNIZING the emerging trend towards multinational design, production, and interchange of civil aeronautical products;

RECOGNIZING the role of Civil Aviation Authorities to coordinate a safe and harmonized introduction of new technologies in the civil aviation system;

DESIRING to enhance cooperation and increase efficiency in matters relating to civil aviation safety on the basis of reciprocity and mutual benefit, within the limitations of the applicable legislation and the budget of each Authority;

NOW THEREFORE, the FAA and the ANAC (collectively, the "Participants", and individually, a "Participant") agree as follows:

I. OBJECTIVES

A. In line with this Letter of Intent (hereinafter referred to as the "Letter"), the Participants intend to cooperate in promoting the safety oversight of eVTOL, including airworthiness and product certification. The principal objectives of this cooperation are (1) to exchange ideas, information, skills, and techniques, and (2) to collaborate on projects and issues of mutual interest in relation to eVTOL.

- B. The objectives of this Letter, with respect to eVTOL, may be achieved through the intent to cooperate in any of the following areas:
 - Establish and maintain recurrent communication at technical level with the purpose of sharing experiences and leveraging knowledge related to certification of eVTOL;
 - 2. Seek joint participation and alignment in international technical groups involved with the development of standards applicable to eVTOL aircraft;
 - 3. Pursue the development or adoption, of common or aligned, technical standards applicable to the certification of eVTOL aircraft;
 - 4. Promote the benefits of concurrent validations to the industry, as a means to facilitate alignment of technical standards and compatibility of the civil aviation systems;
 - 5. Coordinate the early involvement in technical conversations related to the certification of new eVTOL products where validation is intended; and
 - 6. Cooperate on the harmonization of policies, procedures, and practices related to certification of eVTOL.

II. IMPLEMENTATION

A. Specific cooperative activities and technical programs implemented under this Letter are to be delineated and described in subsequent implementing arrangements, under the conditions that are specific to that project, if mutually decided by the Participants.

B. In performing the activities related to this Letter, the Participants may, subject to the

availability of appropriated funds and other resources, facilitate the provision of personnel,

necessary resources, and related support services and cooperate to the extent practicable and

allowable under the applicable domestic laws and regulations of each Participant.

C. Representatives of the Participants (and other agencies and contractors as mutually

decided by the Participants for specific work programs) intend to meet periodically to:

1. Identify and consider proposals for new cooperative activities; and

2. Review the status of ongoing activities that have been carried out under any

implementing arrangements to this Letter.

D. The Participants intend that the release or exchange of information done in line with

this Letter may only be allowable under the applicable domestic laws and regulations of each

Participant.

III. FUNDING

Unless otherwise specified in an implementing arrangement under this Letter, each

Participant intends to bear its costs of the activities it performs under this Letter.

The Participants expressly acknowledge and accept that this Letter merely constitutes a declaration of mutual intent of the Participants without any intent to create any binding commitments or obligations between them.
