Dear Mr Dias,

Thank you for your correspondence of 15 July about the regulation of electronic nicotine delivery systems (ENDS), electronic non-nicotine delivery systems (ENNDS) and heated tobacco products (HTP). I have been asked to reply, and apologise for the delay in doing so.

I shall answer each of your questions in turn.

Question 1: Are ENDS, ENNDS and HTP authorized in your country? If so, through which health legislation/standard are they authorized?

ENDS, ENNDS and HTP are all permitted in the UK. ENNDS, as non-nicotine products, are not covered under our tobacco legislation but under the General Product Safety regulations 2005, which can be found at the link below. There are no age restrictions

These products are regulated through the Tobacco and Related Products Regulations 2016 (TRPR), which are transposed from the EU's Tobacco Products Directive. The Regulations can be found at the following link:

Question 2: Can these products be marketed with the claim that they pose reduced risks to users' health? If so, which risks are reduced, and which scientific evidence supported this decision?

ENDS, ENNDS and HTP cannot be marketed with any health claims in the UK.

However, for e-cigarettes, although health claims cannot be made on the product's packaging (under the TRPR) they can be made in the product's marketing. This must be cleared by the Advertising Standards Authority, within its own rules. You can find more information at the following link:
