

## PUBLIC NOTICE Nº 1/2026/FBN/CCD/CCI

### Program for Supporting the Translation and Publication of Brazilian Authors Abroad

**THE PRESIDENT OF THE NATIONAL LIBRARY FOUNDATION**, in accordance with the powers granted by the Entity's Statute, approved by Decree No. 12,322, of December 19, 2024 (which amends Decree No. 11,233, of October 10, 2022), and the authority delegated by MinC Ordinance No. 18, of April 10, 2023, published in the Official Federal Gazette No. 70, Section 1, Page 28, on April 12, 2023, repealed by MinC Ordinance No. 185, of February 26, 2025, hereby makes public the Public Call Notice for the Program for Support to the Translation and Publication of Brazilian Authors Abroad, in accordance with Article 3 of the Program's Regulation, dated July 1, 2021 (updated on this date in Section I of the Official Federal Gazette).

Article 1. The National Library Foundation will provide financial support:

I. To publishers wishing to translate into any language, publish, distribute, and market abroad, in book form (printed, digital, or both formats), works by Brazilian authors previously published in Brazil in Portuguese;

II. To publishers in the Community of Portuguese Language Countries (CPLP) wishing to publish, distribute, and market works by Brazilian authors in their countries.

Art. 2º. This Notice conforms to the Regulation of the Program for Support to the Translation and Publication of Brazilian Authors Abroad, available on the FBN website: <https://www.gov.br/bn/pt-br/atuacao/cooperacao-e-difusao/apoio-a-traducao/portugues/editais-e-regulamentos>.

Art. 3º. To meet the objectives of this notice, credits are allocated from Management Unit 344042/34209; Work Plan 13.392.5125.20ZF.0001 – Promotion and Incentive to Brazilian Culture; PTRES: 235.867; Source: 1000; Internal Plan: SFL20262551 – Literary Translation Grants Notice. The granting of financial support is subject to budgetary availability.

Art. 4º. Applications must be submitted exclusively through the platform of the Program for Supporting the Translation and Publication of Brazilian Authors Abroad, via the following link:
