Drafting the Complete List of Publications

Please adhere to the following instructions. You may refer to our [FAQs](#) for further information. Failure to comply with these requirements may result in delays in processing your application.

- Please draw up a complete list of publications in reverse chronological order using the following template. We cannot accept lists that are structured differently.
- The list of publications submitted to the Humboldt Foundation **may not** be amended to include additional publications during the selection procedure.
- At the top of your list of publications, please indicate which of the publications cited derive from your dissertation.
- **Before uploading, please verify the accuracy of the information provided in your publication lists** (complete list, list of key publications). Please ensure that you:
 - List all names in the correct order,
 - Indicate all individuals with whom you share lead authorship (see example B1) or corresponding authorship,
 - List the title of the paper exactly as published,
 - Provide the correct name of the publication medium.

Information that does not match the actual publication can lead to rejection of your application on formal grounds and may furthermore constitute a violation of the [Rules of Good Scientific Practice](#), e.g. the requirement to be truthful regarding the contributions of partners, resulting in sanctions.

- Each publication may only be listed once in the publication list. Inclusion in multiple categories is not permitted (see example E1).
- If you include works that are not in German or English, please cite the title in the original language as well as a German or English translation (see example C2).
- Please only provide title and authors for the submitted publications (see section E).
- In your list of publications you are not permitted to include works that have not yet been submitted for publication.
