CLÁUSULA PRIMEIRA – DO OBJETO

O presente Termo Aditivo tem por objeto a prorrogação da vigência do comodato dos veículos e as alterações da cláusula primeira e da cláusula quarta, alínea “f”, conforme Subcláusulas abaixo:

**Subcláusula Primeira** – As Partes decidem em comum acordo prorrogar a vigência do Contrato por mais 12 (doze) meses, passando a vigor até 23 de janeiro de 2027.

**Subcláusula Segunda** – O prazo de vigência deste contrato de comodato poderá ser prorrogado, antes de findo o prazo ora convencionado, desde que haja o consenso entre as Partes.

**Subcláusula Terceira**- As Partes decidem em comum acordo que a Cláusula Primeira do Contrato de Comodato passará a vigorar conforme abaixo:
