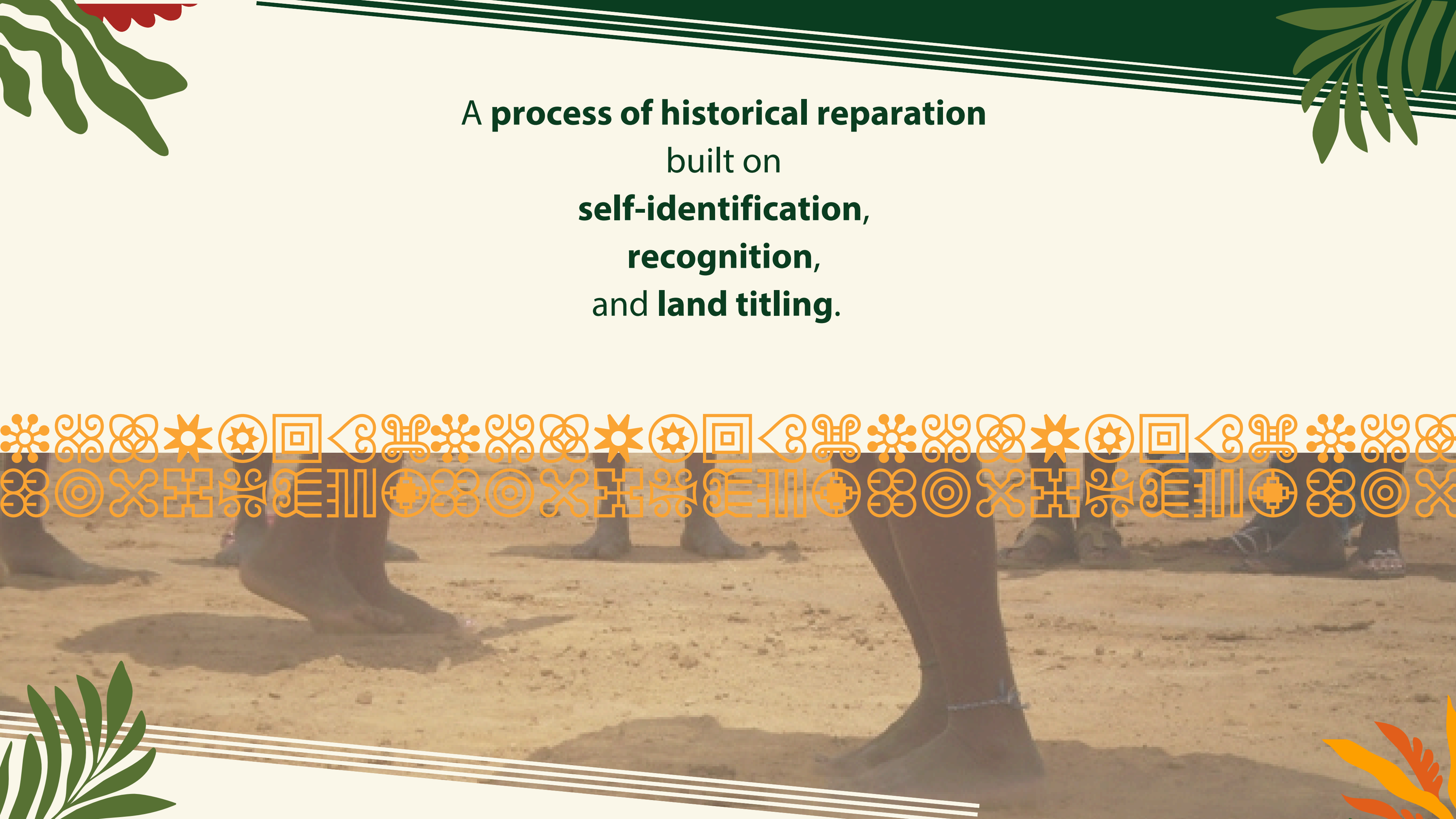


**What is the land regularization of

and **land titling.**

with land regularization?**





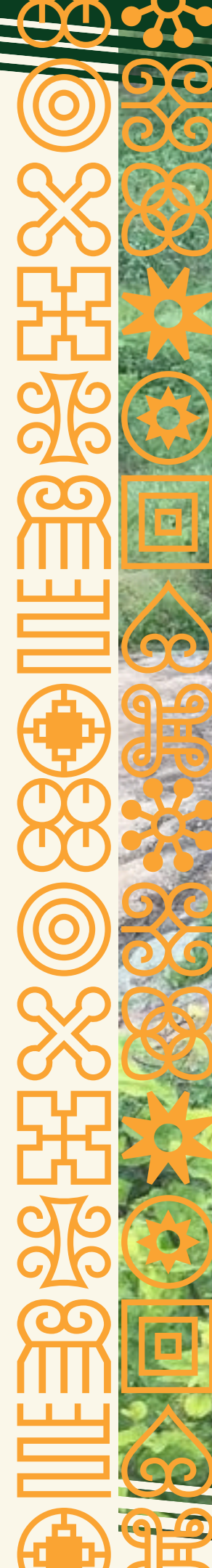
Land regularization is vital  
to safeguarding human lives that are deeply intertwined  
with the biodiversity of their environment:

In the quilombola way of life,  
**caring for our own means caring for the land.**





**Why is land titling  
strategic in confronting  
the climate crisis?**





Research shows that, beyond serving as carbon sinks, titled quilombola territories have deforestation rates up to 55% lower than untitled lands. Land titling acts as a barrier against land grabbing, illegal logging, and the predatory expansion of agribusiness.





# **The Quilombola Agenda in Climate Change Mitigation**





**Recognizing and affirming the central  
role of quilombola communities in  
preserving Brazil's biomes.**





- **Titling quilombola lands;**
- **Recognizing quilombola production practices as sustainable and environmentally restorative;**
- **Acknowledging and valuing the environmental assets of quilombola lands.**







## Proposals for a Quilombola Agenda for the Climate Plan (1)

Expand productive restoration and sustainable land management in agrarian reform settlements and **in collective territories.**

Reduce legally permitted deforestation of native vegetation in rural properties, agrarian reform settlements, **and quilombola territories.**

Prevent and reduce fires in native vegetation across rural properties, agrarian reform settlements, and quilombola territories by **incorporating and valuing traditional fire management practices.**









## Proposals for a Quilombola Agenda for the Climate Plan (2)

Restore native vegetation in private rural properties, agrarian reform settlements, and quilombola territories, **incorporating sub-indicators and species of cultural and nutritional importance.**

As part of efforts to implement and strengthen initiatives that value environmental assets, set a goal to **create payment for environmental services (PES) programs that ensure fair, direct compensation to quilombola territories, along with measures that recognize the value of their environmental assets.**








## Proposals for a Quilombola Agenda for the Climate Plan (3)

Promote initiatives for land regularization, territorial planning, and technical assistance and rural extension for smallholders, **quilombola communities, and other traditional communities.**

Develop and implement Quilombola Territorial and Environmental Management Plans (QTEMP) with technical support and sustainable development incentives.

Establish formal mechanisms and platforms to ensure the full, effective, and equitable participation of quilombola representatives, with particular attention to gender and generational balance, across all areas of sectoral climate governance.





## Proposals for a Quilombola Agenda for the Climate Plan (4)

Develop and implement a participatory monitoring system for land regularization in quilombola territories through INCRA's Territorial Management Platform.
