

## INPI BR Authority File Definition File

This authority file contains information about all the publication documents issued by the Brazilian National Institute of Industrial Property (INPI BR) related to Patents of Utility Models, Patents of Invention and Certificates of Addition, according to the Brazilian IP Law.

The format of the data follows the established by the Committee of WIPO Standards (CWS) in the Standard 37 (ST.37) and is made available in XML format.

## **Data Elements**

This Authority File contains the following data elements:

- Two-letter alphabetic code of publication authority – “BR” (WIPO ST.3);
- Publication number;
- Kind code of the patent document (kind-of-document code);
- Publication date;
- Publication exception code (see section below);
- Indication of whether the abstract, description, claims of a publication are text-searchable, through selection of one of the following codes:
  - “N” – Not available
  - “U” – Unknown
  - Two-letter language code(s) in which the searchable text is available, either in the original language or as an official translation

At this moment, text data for Brazilian patent documents are only made available in Portuguese (“pt” language code).

## **Exception Codes**

The following exception codes are being used in the authority file generated:

<b>Exception Code</b>	<b>Description</b>
M	Publication documents with no electronic document and for which the paper documentation was not located.
P	Documents available on paper only
R	Publication correcting bibliographical information.
X	Publication events for which no document was generated. For example, no corrected title page was generated after changes in bibliographical data occurred (a document kind code “8” is assigned) until 2017;

Deleted publication documents (exception code “D”) were not mapped at this version of the Authority File.

## **Divisional Applications**

It is important to state that until 2023 no publication document was generated for divisional applications filed after the publication of the original application. Technical matter contained in those documents can be found in the original application.
