Report prepared based on the information submitted by the Judiciary regarding the court-ordered payments (precatórios) filed against the Federal Treasury up to April 2, 2025, pursuant to § 5 of Article 100 of the Federal Constitution, in accordance with § 4 of Article 33 of the 2026 Budget Guidelines Bill (National Congress Bill No. 2 of 2025).

Precatórios are court-ordered payment requests issued by the Judiciary for the enforcement of payment obligations imposed on the Public Treasury as a result of final and unappealable judicial decisions.

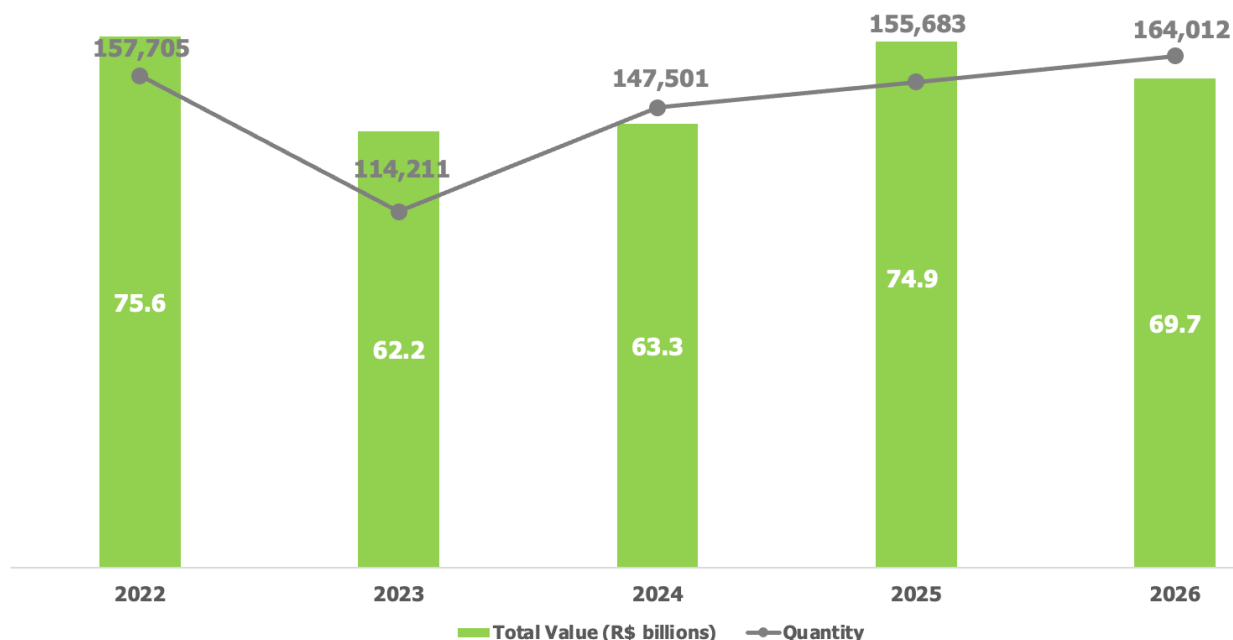

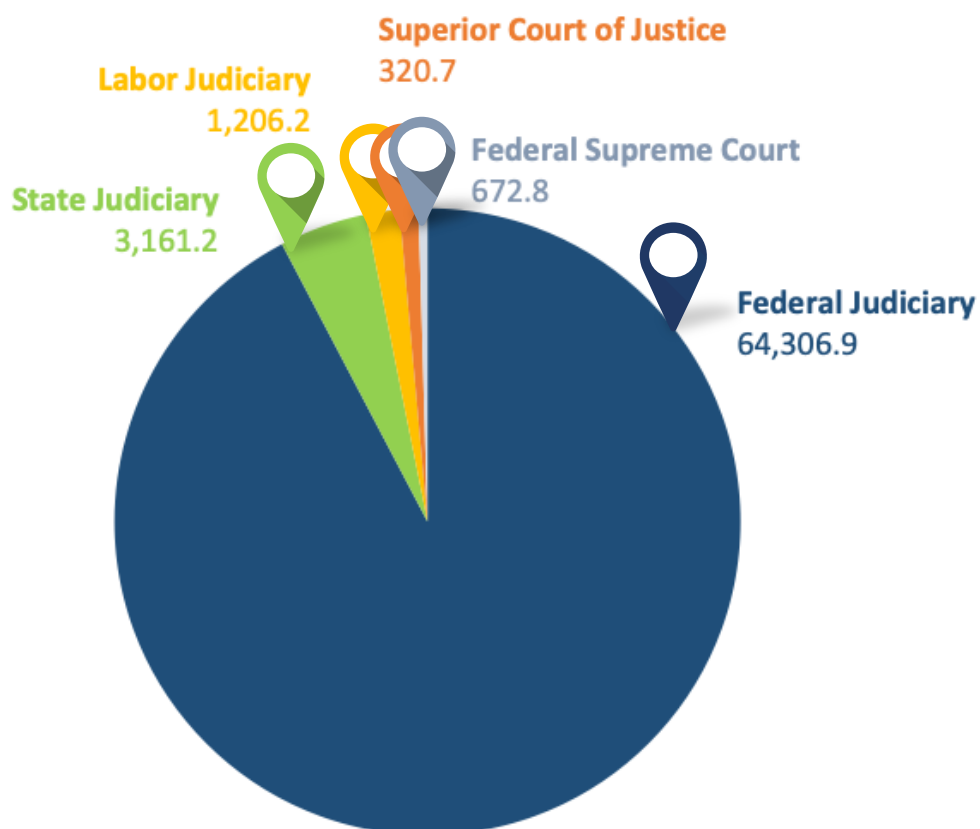

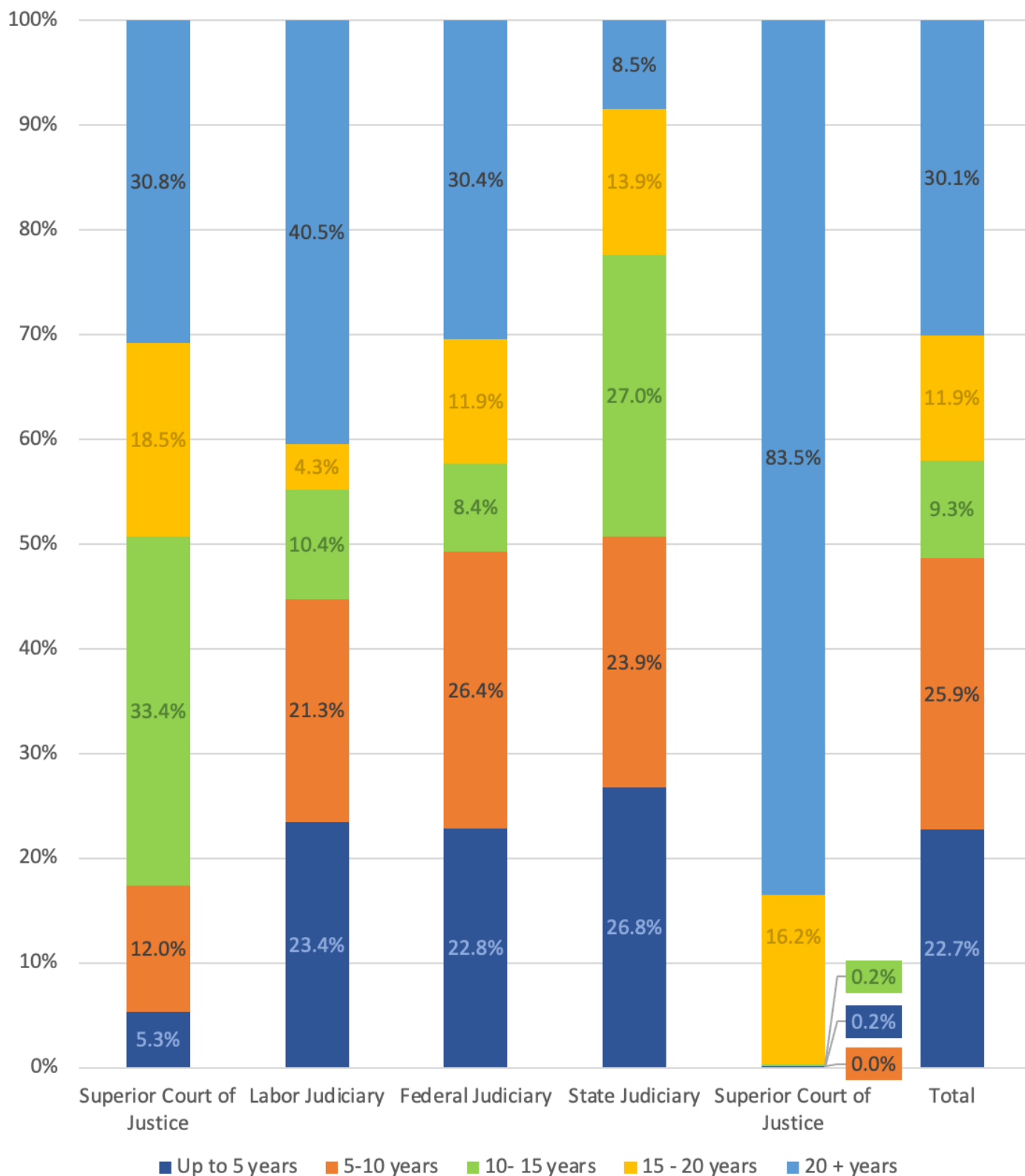

Distribution of court-ordered payments issued (as % of the total value), considering the time elapsed between the date the original lawsuit was filed and the date of its issuance.



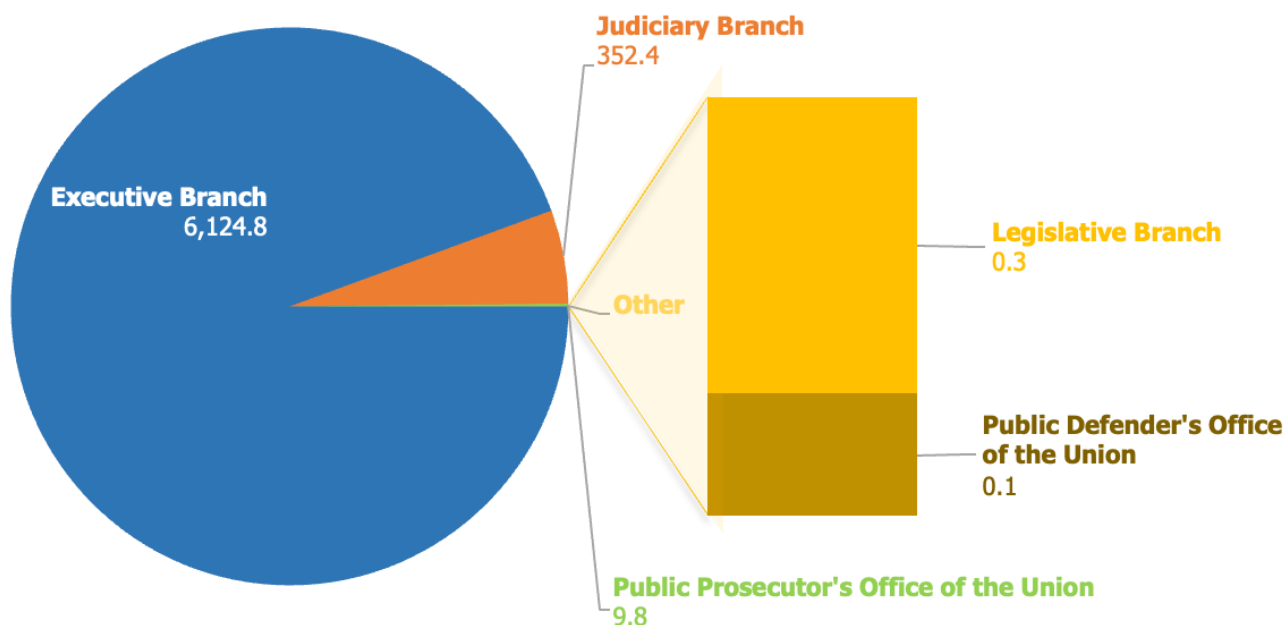

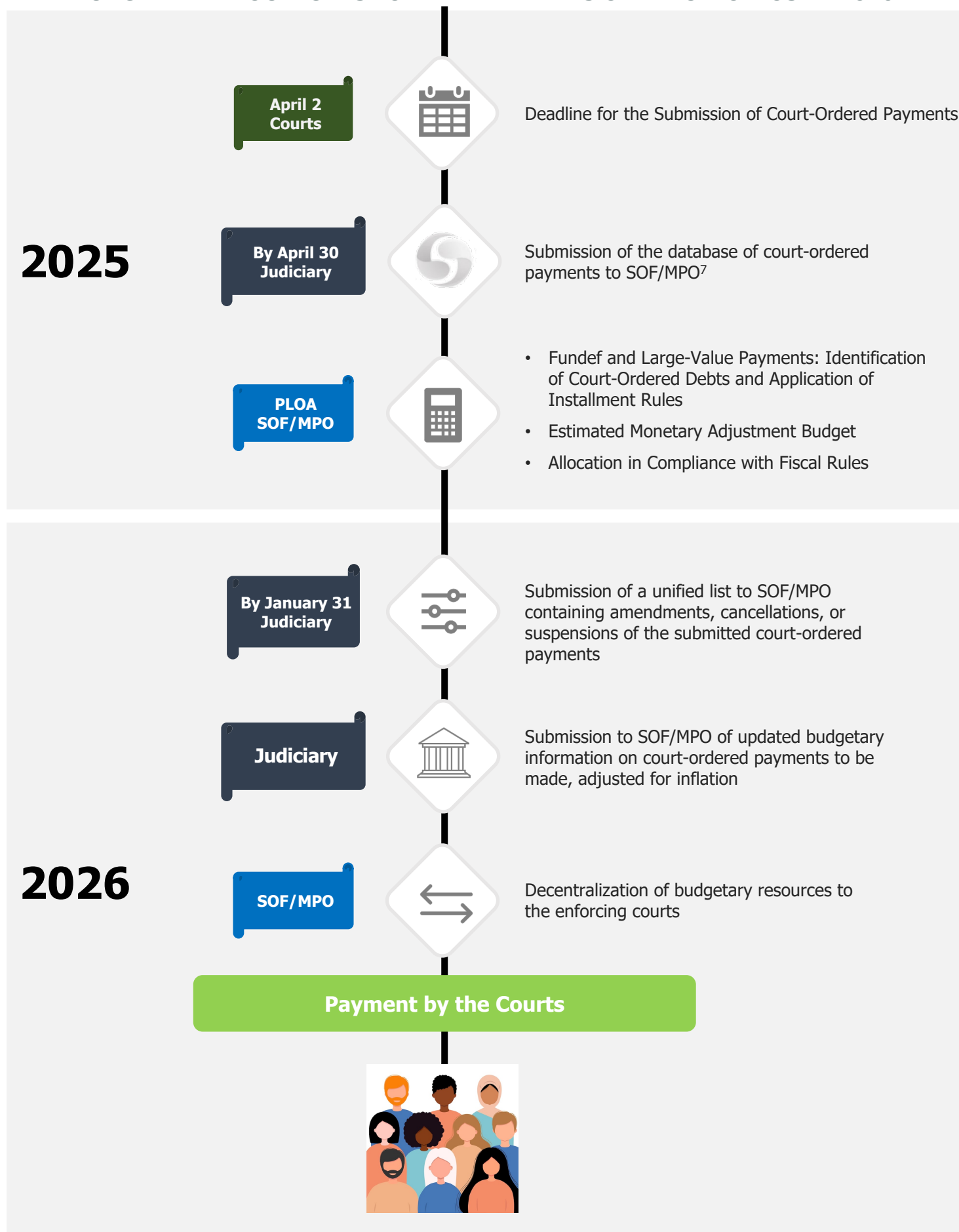
