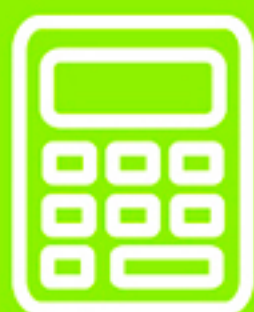
Active participation in building a fairer and more supportive society!
