## Observação

Tendo em vista a conclusão, em 2 de julho de 2025, das negociações do Acordo de Livre Comércio entre o MERCOSUL e a EFTA, o Brasil decidiu publicar os textos negociados com o objetivo de assegurar o efetivo exercício do direito de acesso à informação pública e a transparência da gestão pública.

Ressalta-se que os textos disponibilizados têm caráter exclusivamente informativo e poderão sofrer modificações adicionais em decorrência do processo de revisão legal, sem prejuízo dos compromissos assumidos.

Os textos definitivos serão publicados após a assinatura do Acordo. O Acordo será vinculante para as Partes, nos termos do direito internacional, somente após a conclusão dos procedimentos legais internos necessários à sua entrada em vigor.

## APPENDIX 5 TO ANNEX I

## EXTENDED CUMULATION

- 1. The cumulation provided for in paragraph 4 of Article 6 (Cumulation of Origin) of Annex I (Rules of Origin) may be applied to materials from the EU if they qualify as originating materials under the relevant preferential trade agreement between the EU and an EFTA State for products exported to MERCOSUR, or under a preferential trade agreement between the EU and MERCOSUR<sup>1</sup> for products exported to an EFTA State, provided that:
  - (a) the product-specific rules (PSR) for a given material are identical between the EFTA States and MERCOSUR and between MERCOSUR and the EU; or<sup>2</sup>
  - (b) the PSR for a given material are deemed equivalent by the EFTA States and MERCOSUR;
    - and in both cases,
  - (c) the given material originating in the EU meets the criteria as set out in Attachment I.
- 2. Attachment I lists all materials where cumulation under paragraph 1 is applicable.
- 3. If the EFTA States and MERCOSUR deem additional PSR for a given material identical or equivalent, Attachment I may be amended by the Joint Committee upon recommendation from the Sub-Committee on Trade in Goods.
- 4. The EFTA States and MERCOSUR shall endeavour to promote similar provisions as in this Appendix with the EU.
- 5. With regard to the implementation of this Appendix, or any other matter that the EFTA States and MERCOSUR might consider arising from the application of this Appendix, the EFTA States and MERCOSUR shall, upon request of a Party, without undue delay review this Appendix.
- 6. The Parties shall no later than five years from the entry into force of the Agreement jointly review this Appendix.

For greater certainty, in the case of exports from MERCOSUR to an EFTA State, while no preferential agreement is applied between MERCOSUR and the EU, these criteria will be applied by the MERCOSUR exporters without the need to present any element confirming that the materials used are originating in the EU.

Notwithstanding paragraph 4 of Article 6 of Annex I (Rules of Origin), if no preferential trade agreement is applied between MERCOSUR and the EU at the entry into force of the Agreement, an exporter may nevertheless apply extended cumulation as otherwise provided for in paragraph 1.

7. Footnotes 1 and 2 shall apply for four years from the entry into force of the Agreement, unless otherwise decided by the Joint Committee. In the event that footnote 1 ceases to apply, the Parties shall without undue delay decide on a mutually acceptable solution.
