Observação

Tendo em vista a conclusão, em 2 de julho de 2025, das negociações do Acordo de Livre Comércio entre o MERCOSUL e a EFTA, o Brasil decidiu publicar os textos negociados com o objetivo de assegurar o efetivo exercício do direito de acesso à informação pública e a transparência da gestão pública.

Ressalta-se que os textos disponibilizados têm caráter exclusivamente informativo e poderão sofrer modificações adicionais em decorrência do processo de revisão legal, sem prejuízo dos compromissos assumidos.

Os textos definitivos serão publicados após a assinatura do Acordo. O Acordo será vinculante para as Partes, nos termos do direito internacional, somente após a conclusão dos procedimentos legais internos necessários à sua entrada em vigor.

The Schedule of Specific Commitments for the individual services sectors and sub-sectors is elaborated on the basis of a positive list approach and are identified in accordance with the classification list in Document MTN.GNS/W/120 of the WTO and corresponding CPC preliminary version numbers.

Where no reference is made to one or more mode of supply for a specific sector or subsector, it should be interpreted that Paraguay is not taking any commitments for that specific sector or sub-sector.

Specific conditions

This schedule of specific commitments is based on the assumption that the Agreement shall not interfere with existing bilateral agreements relating to taxes and tax measures or with the capacity of Paraguay to pursue the objectives of its fiscal policies.
