WHEREAS the National Front of Mayors (FNP) is the only national municipal entity managed exclusively by mayors in the exercise of their mandates and aims to promote active participation of local entities in broad and democratic dialogue on urban issues with the three powers at the state and federal levels as well as organized civil society.

WHEREAS the University of Brasília (UNB) is a reference in teaching, research and extension, with local, regional and international insertion. Evaluated by the Ministry of Education as the best university in the Central-West region.

WHEREAS the UN Global Compact Network Brazil is the largest corporate sustainability initiative in the world, bringing together more than 21,000 members and is a call to companies to align their strategies and operations with universal principles on human rights, labor, environment and anti-corruption, and increase commercial ambition to achieve sustainable development goals.

WHEREAS the Water, Energy, and Basic Sanitation Regulatory Agency of the Federal District (ADASA) is the only regulatory agency in Brazil that simultaneously regulates the natural resource water (a state responsibility) and basic sanitation services (a municipal responsibility). And that ADASA aims to promote the sustainable management of water resources and the quality of regulated public services for the benefit of society.

WHEREAS the Brazilian Association of Municipalities (ABM) is directly linked to the fight for the rights of local autonomy and sustainable development of Brazilian cities and its mission is to promote union and cooperation between municipalities, aiming to create public policies that meet the needs of the population, with the aim of guaranteeing the autonomy and independence of cities, as well as valuing the role of municipalities in the Brazilian federation.

WHEREAS the Federation of Commerce of Goods, Services and Tourism of the Federal District (FECOMERCIO) is a non-state higher level trade union body. It is responsible for managing the Fecomercio System in the DF. In addition to the federation itself, the Fecomercio Institute (IF), the National Service for Commercial Learning (SENAC) and the Social Service of Commerce (SESC) are part of this system.

WHEREAS the National Association of Municipalities and the Environment (ANAMMA) is a civil entity, non-profit or partisan, representing municipal power in the environmental area, with the objective of strengthening Municipal Environmental Systems for the implementation of environmental policies that will preserve natural resources and improve the quality of life of citizens.

WHEREAS the Economic Development Council (CODESE/DF)'s central objective is to actively participate in the sustainable economic planning of Brasília and its surroundings, in the short, medium and long term.

WHEREAS the Commercial Association of the Federal District (ACDF) is the oldest class representative entity in the Federal District. Since June 15, 1998, ACDF has facilitated and supported its projects and actions at the ACDF Institute. Its mission is to represent its members and their economic or professional activities, collectively before the constituted powers, guiding, supporting and developing actions that promote their rights, interests and economic, cultural and social development in the Federal District and surrounding areas.

WHEREAS the Institute of Advanced Studies of the University of São Paulo (IEA-USP) operates as an interface for the dynamics of Sciences, Humanities, Art and Culture, dialoguing with epistemologies, contexts and transdisciplinary aspects with the aim of integrating knowledge and offering society subsidies, alternatives and formulations on scientific, social, political, economic, environmental and cultural issues that contribute to the development of public and political policies.

WHEREAS the European Waste Management Association (FEAD) represents the private waste management and resources industry across Europe and aims to advocate for a better regulatory framework for the waste management sector, achieve the best economic and environmental results and reinforce the circular economy in Europe.

WHEREAS the Valoriza Waste Institute aims, with advanced practices of engagement, communication and knowledge production, to promote broad awareness and influence public policies on the collection, recycling, treatment and ecologically correct disposal of waste, aiming for a more sustainable future.

WHEREAS the Energy from Waste Conference is an event that offers an unparalleled opportunity to meet with operators, project developers, investors, technology providers, waste authorities and government representatives, to explore the role of waste to energy in developing the circular economy and in the transition to net zero emissions.

WHEREAS the Energy from Waste Network (EfW) is an online hub for industry experts and provides a space to meet and share ideas, track industry issues and network.

WHEREAS the Parties wish to cooperate in areas of mutual concern related to UNDP's development efforts.

WHEREAS, in 2024, the Parties joined forces to hold the 2nd edition of the "International Conference on Solid Waste and Sanitation – CIRSOL", in Brasília, Federal District.

WHEREAS the Parties wish to expand partnerships to hold the 2nd edition of the "International Conference on Solid Waste and Sanitation – CIRSOL".

NOW, THEREFORE, the Parties wish to express their intention to cooperate as follows:

Article I

Purpose and Scope

The objective of this MOU is to create the cooperation structure and facilitate collaboration between the Parties, in areas of common interest and on a non-exclusive basis, in the areas of cooperation identified in article II below, aiming to hold the “International Waste Conference Solids and Sanitation – CIRSOL”, which, in turn, aims to stimulate debate on solid waste and sanitation at a multisectoral level; contribute to ensuring compliance with the 2030 Agenda, the Brazilian Nationally Determined Contribution (NDC) and the National Solid Waste Policy (PNRS, 2010); work on human valorization and economic and social inclusion of workers in the solid waste and sanitation sector; and reiterate Brazil's international commitments to the Paris Agreement.

Article II

Areas of Cooperation

The Parties have identified the following activities in which cooperation may be pursued, with each Party operating subject to its respective mandates, governing regulations, rules, policies and procedures:

- ii) Support the facilitation and coordination, flow of information and exchange between the parties and other institutions, organizations and subnational, national and international actors relevant to the development of the activities of the agreed object.
- iii) Provide data, information and guidance related to the execution of activities that are relevant to the preparation and construction of the “International Conference on Solid Waste and Sanitation-CIRSOL”.
- iv) Propose, coordinate and facilitate activities related to CIRSOL programming, such as plenary sessions, debate tables, hackathon challenges, sustainable business fair activities, environmental education actions, etc.

- viii) Adopt complementary measures relevant and necessary for the faithful execution of the Project, subject to approval by the other parties.

Article III

Consultation and Exchange of Information

3.1 The Parties will, on a regular basis, keep each other informed of and consult on matters of common interest, which in their opinion are likely to lead to mutual collaboration.

3.2 Consultation and exchange of information and documents under this MOU will be without prejudice to arrangements, which may be required to safeguard the confidential and restricted character of certain information and documents. Such arrangements will survive the termination of this MOU and of any agreements signed by the Parties within the scope of this collaboration.

3.3 The Parties will, at such intervals as deemed appropriate, convene meetings to review the progress of activities being carried out under the present MOU and to plan future activities.

3.4 The Parties may invite each other to send observers to meetings or conferences convened by them or under their auspices in which, in the opinion of either Party, the other may have an interest. Invitations will be subject to the procedures applicable to such meetings or conferences.

Article VIII

Legal Provisions Relating to Implementation

8.1 Notwithstanding anything in this MOU to the contrary, (a) this MOU is an expression of intent and does not constitute a legally binding document; (b) nothing herein shall be construed as creating a legally binding commitment, financial or otherwise; (c) nothing herein shall be construed as creating a joint venture and neither Party shall be an agent, representative or joint partner of the other Party; (d) all of UNDP's activities envisaged hereunder are subject to the availability of funding; (e) any funds received by UNDP shall be used, and all UNDP activities further to this MOU will be carried out, in accordance with the project documents agreed between UNDP and the concerned programme government(s) where the activities will be implemented, and in accordance with the applicable UNDP regulations, rules, policies and procedures; and (f) each Party shall be responsible for its acts and omissions and those of its employees, contractor and subcontractors, in connection with this MOU and its implementation.

8.2 To the extent that the Parties wish to create legal or financial obligations with respect to or resulting from any activity contemplated in this MOU, a separate agreement related thereto will be concluded between the Parties prior to such activity being undertaken.

8.3 The Parties will consult each other, as appropriate and if circumstances so require, on issues relating to intellectual property and rights thereto, including the necessity of entering into separate agreement(s) to regulate such issues and rights.

8.4 In the event of inconsistency between any provision of this Article VIII and a provision of another section of the MOU, this Article VIII shall prevail.

Article IX

Settlement of Disputes

Any dispute, controversy or claim between the Parties arising out of this MOU which is not settled amicably by the Parties shall be referred to arbitration under the United Nations Commission on International Trade Law (UNCITRAL) Arbitration Rules then in force. The arbitral tribunal shall have no authority to award punitive damages. The Parties shall be bound by any arbitration award rendered as a result of such arbitration as the final adjudication of any such controversy, claim or dispute.
